VAIL GOLF CLUB SEASON PASS/RESIDENT ID FOR INDIVIDUALS

RESIDENCY REQUIREMENTS

Residency requirements for individuals who want to qualify for in-district discounted rates and issuance of a resident rate or golf pass are:

1. An individual who owns (or whose spouse owns) not less than 50% interest in taxable real estate within the District boundaries and therefore is assessed a mill-levy tax by the VRD.

OR

2. In the case of an individual who leases, a Colorado driver's license at the lease address must accompany application. Lease must run through end of the season or termination date will be placed on the face of pass. Right to pass terminates if lease terminates or applicant moves out of district. Lease must be for at least six months. Lease must contain landlord or property management company phone number for verification purposes.

RESTRICTIONS ON MULTIPLE OWNERS OF PERSONAL OR REAL PROPERTY

Multiple, partnership, or corporate owners of real or personal property may have up to four individuals eligible for the pass/I.D. card program as long as their name appears on the property tax bill.

PROPERTIES NOT INCLUDED IN THE VAIL RECREATION DISTRICT BOUNDARIES

The Vail Golf Club pass/I.D. program is only available to owners of real and/or personal property within the Vail Recreation District (VRD) who are assessed a mill-levy tax by the Vail Parks and Recreation District. Residency within the boundary limits of the Town of Vail does not guarantee taxes are paid to the VRD. Although the District boundary is most of the area generally considered to be the Town of Vail, certain parcels are not within the District. Additionally, portions of certain subdivisions that are not part of the Town of Vail are part of the District.

INTERVAL OWNERSHIPS

A timeshare owner who can establish his/her ownership during the time period of their stay in Vail may be eligible for a golf pass or I.D. card valid only during the period of their ownership. Interval owners must provide a) copy of the deed and b) letter from the management association confirming the exact dates of the ownership period.

WHO ARE "IMMEDIATE FAMILY MEMBERS?"

Season passholders may obtain golf passes / resident I.D. cards (qualifying Vail Residents for the Resident rate during peak and fall season) for their immediate family members. Immediate family members include a spouse or any dependent children under the age of 18.

Anyone using false identification or information in obtaining an ID card and/or recreational pass will forfeit the card or pass without refund. Police will be notified to prosecute for "theft of services," trespassing and violation of the District's rules and procedures.

CANCELLATION POLICY

- Tee times must be cancelled at least 4 hours in advance by calling the Vail Golf Club pro shop at 970-479-2260.
- The charge for a no-show or no-cancellation call is \$50.
- The passholder/I.D. holder who made the tee time will be held responsible for the cancellation fee, and their credit card may be charged.

2026 VAIL & EAGLE COUNTY RESIDENT SEASON PASS OPTIONS

Vail Resident Platinum Pass: \$2,700

Tee times may be reserved fourteen (14) days in advance. This pass includes green fee, cart rental and range pass, locker and club storage. Vail residents must prove residency at time of purchase. The pass will not be honored until all residency qualifications are met. Proof is the responsibility of the purchaser. Limited to 25 passes sold.

Eagle County Platinum Pass: N/A

Vail Resident Gold Pass: \$1,900

Tee times may be reserved ten (10) days in advance. This pass includes green fee, cart rental and range pass. Vail residents and Eagle County Residents must prove residency at time of purchase. The pass will not be honored until all residency qualifications are met. Proof is the responsibility of the purchaser.

Eagle County Gold Pass: \$2,200

Vail Resident Silver Pass: \$1,150

Tee times may be reserved seven (7) days in advance, but are restricted to only allow play after 12 p.m. on Friday, Saturday, Sunday, and Holidays during the Peak Season (June 19–September 20). This pass includes only a passholders green fee unless they choose to upgrade to the unlimited golf cart pass. This pass includes only a passholders green fee. Vail and Eagle County residents must prove residency at time of purchase. The pass will not be honored until all residency qualifications are met. Proof is the responsibility of the purchaser.

Eagle County Silver Pass: \$1,450

Young Adult Pass (Ages 18-29 as of May 1, 2026): \$900

Tee times may be reserved seven (7) days in advance, but are restricted to only allow play after 12 p.m. on Friday, Saturday, Sunday and Holidays during the Peak Season (June 19–September 20). This pass includes only a passholders green fee unless they choose to upgrade to the Young Adult Pass with Golf Cart. Vail and Eagle County residents must prove residency at time of purchase. The pass will not be honored until all residency qualifications are met. Proof is the responsibility of the purchaser.

Young Adult Pass with Golf Cart: \$1,300

Vail Resident Bronze Pass: \$950

Tee times may be reserved three (3) days in advance ONLY after 2 p.m. throughout the 2026 season. This pass includes only a passholders green fee unless they choose to upgrade to the unlimited golf cart pass. Vail and Eagle County residents must prove residency at time of purchase. The pass will not be honored until all residency qualifications are met. Proof is the responsibility of the purchaser.

Eagle County Bronze Pass: \$1,150

Junior Gold Pass: \$700

Tee times may be reserved three (3) days in advance, but are restricted to only allow play after 12 p.m. on Friday, Saturday, Sunday, and Holidays during the peak season (June 19–September 20). This pass only includes a players green fee, and valid license must be presented for golf cart use. This pass includes a \$100 driving range card. Juniors must pass Rules & Etiquette Test. The pass will not be honored until qualifications are met.

Eagle County Junior Gold Pass: \$700

Junior Silver Pass: \$500

Tee times may be reserved three (3) days in advance, but are restricted to only allow play after 12 p.m. throughout the 2026 season. This pass only includes a players green fee, and valid license must be presented for golf cart use. This pass includes a \$100 driving range card. Juniors must pass Rules & Etiquette Test. The pass will not be honored until qualifications are met.

Eagle County Junior Silver Pass: \$500

Junior Bronze Pass: \$250

Tee times may be reserved three (3) days in advance, but are restricted to only allow play after 2 p.m. throughout the 2026 season. This pass only includes a players green fee, and valid license must be presented for golf cart use. Juniors must pass Rules & Etiquette Test. The pass will not be honored until qualifications are met.

Eagle County Junior Bronze Pass: \$250

Parent-Junior Pass with Cart: \$700

Parent-Junior passholders may book tee times seven (7) days in advance, but are restricted to only allow play after 3:30 p.m. throughout the 2026 season. Golf cart and range balls are included on the day of play. Pass is only valid when the designated parent and designated child (aged 17 or under as of May 1, 2026) are both present. Additional junior golfers can be added using the Junior Gold / Silver / Bronze Options.

Eagle County Parent-Junior Pass with Cart: \$700

2026 VAIL AND EAGLE COUNTY RESIDENT PUNCH CARD OPTIONS

- Punch cards are fully transferable but must be purchased by Vail or Eagle County Resident with designated proof or residency.
- Punch cards are comprised of 20, 9-hole punches and must be punched twice for an 18-hole round
- Punch card holders are limited to eight (8) punches per day: equivalent to eight (8) 9-hole rounds or four (4) 18-hole rounds.
- Punch cards are treated the same as cash, and there will be no compensation for lost cards.
- All punch cards expire following the conclusion of the 2026 season, and are not eligible to be rolled into the 2027 season.

Vail Resident Gold Punch Pass: \$1,050

Eagle County Gold Punch: \$1,200

Tee times may be reserved ten (10) days in advance any time throughout the 2026 season. This pass includes green fee, cart rental and range pass. Vail residents and Eagle County Residents must prove residency at time of purchase. The pass will not be honored until all residency qualifications are met. Proof is the responsibility of the purchaser.

Vail Resident Silver Punch Card: \$800

Eagle County Silver Punch Card: \$950

Tee times may be reserved seven (7) days in advance, but are restricted to only allow play after 12 p.m. on Friday, Saturday, Sunday and Holidays during the Peak Season (June 19-September 20). This pass includes only a passholders green fee. Vail and Eagle County residents must prove residency at time of purchase. The pass will not be honored until all residency qualifications are met. Proof is the responsibility of the purchaser.

Vail Resident Bronze Punch Card: \$600

Eagle County Bronze Punch Card: \$750

Tee times may be reserved three (3) days in advance ONLY after 2 p.m. throughout the 2026 season. This pass includes only a passholders green fee. Vail and Eagle County residents must prove residency at time of purchase. The pass will not be honored until all residency qualifications are met. Proof is the responsibility of the purchaser.

2026 VAIL GOLF CLUB PASSHOLDER/RESIDENT RULES

Initial Box

- Conduct:** Any misconduct deemed serious by Vail Golf Club staff may result in pass being **revoked** or **suspended**. Any verbal threat or physical contact directed toward a member of the Vail Golf Club or Grill on the Gore staff shall be deemed to be serious misconduct and will result in disciplinary actions.

- Liquor License:** The Vail Recreation District owns the liquor license for the entire Vail Golf Club and Grill on the Gore restaurant. Colorado State Law prohibits the consumption of alcohol on property **not purchased** from the property. Any passholder with off-premise alcohol with the intent to consume will face disciplinary actions.

- Pace of Play Guidelines:** In the interest of a positive experience for all users of the course, Vail Golf Club strictly enforces a four (4) hour and seven (7) minute 18-hole round. All golfers are expected to complete the first nine holes of play in or under **two hours and two minutes** and to continue on this pace through the 18th green. Our staff is here to assist you in any way possible and to help you play in a timely fashion.

Please respect our policy and our staff as they implement the course policy. Vail Golf Club Staff has been charged with maintaining the appropriate pace of play, and to that end, the staff is authorized and required to direct you to play faster, skip holes if out of position or leave the course if unwilling to work with our staff to complete play in a timely manner.

- Dress Code Enforced:** Collared shirts and proper golf attire required for season passholders. No denim, tank tops or cut-offs are allowed on the course or practice facility.

- Check In:** Players must check in for play at the pro shop 15 minutes prior to play. Your starter slip will be generated in the pro shop. You must present your receipt to the starter prior to play.

- Reservation Rules:** Pass and Punch Card holders are required to follow all tee time reservation rules presented above on the pass application. Passholders who continually do not follow their tee time reservation rules may face disciplinary action.

- Golf Carts:** All golf cart users must have a valid driver's license. Users are responsible for any cart damage while operating the vehicle.
