Vail Recreation District February 23, 2023, Meeting Minutes

- 10.1 Mr. Mike Ortiz shared with the board that the Town of Vail reviewed the POPULOUS (selected design firm) contract. He explained that there was a great deal of expense on the front end of the contract because of the amount of engineering that is needed. Specifically, the engineering of the roof of Dobson Arena needs to be investigated before any programming considerations can be made. Mr. Ortiz will share with the board once the engineering review is done.
- 10.2 Mr. Kirk Hansen shared with the viewing public a background of POPULOUS' projects and resume and his excitement to have a great firm working on the project.
- 10.3 Mr. Bob Armor reviewed a brief timeline of what the project has been through, starting with the Town of Vail putting the project out for RFP in November 2022, to awarding the project to POPULOUS in January 2023. He shared that the TOV has approved \$345 thousand for phase 1 of design services. Mr. Armour also shared that discussions are started about Dobsons down time. Many different interested parties have been in discussions about the best place for a sheet of ice and are working together to put a timeline together. Mr. Ortiz shared that a portable rink vendor has been found. The vendor is Rink-Tec International, they have systems that are used throughout many states and Canada. Mr. Ortiz shared that the next step will be working on finding a partner with land and encouraging a partnership among all the recreation agencies, Hockey and figure skating clubs and local government agencies in Eagle County.
11. EXECUTIVE DIRECTOR REPORT
- 11.1 Mr. Mike Ortiz shared a few highlights from the director's report that can be found on the website in the board packet. He highlighted the Vail Uphill race and the successful outcome it had again this year. He also shared the success of the National Brotherhood of Skiers event held at Dobson Arena.
12. BOARD MEMBER INPUT
- 12.1 Director Hanson recognized the great job our marketing department was doing with content ads. He also shared that the district has planned \$2.8 million in capital projects for 2023. He highlighted some of the projects for the viewing public.
- 12.2 Director Plate thanked Mike Ortiz for all his work on Dobson and Scott O'Connell and his food & beverage team for their work on the National Brotherhood of Skiers event.
- 12.3 Director Rediker asked for clarification on parking at Lionshead for a Dobson event. Mr. Ortiz confirmed that when someone parks in Lionshead for a Dobson event that Dobson has a voucher for 2 hours free of charge. This voucher covers most of Dobsons events.

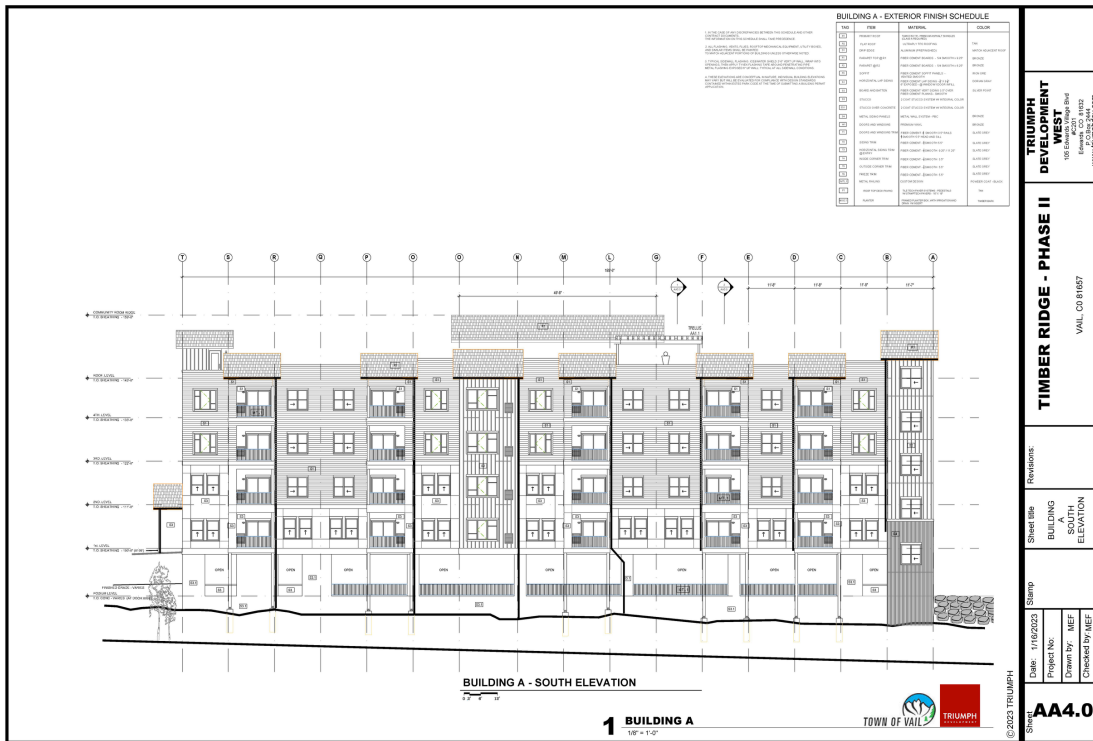


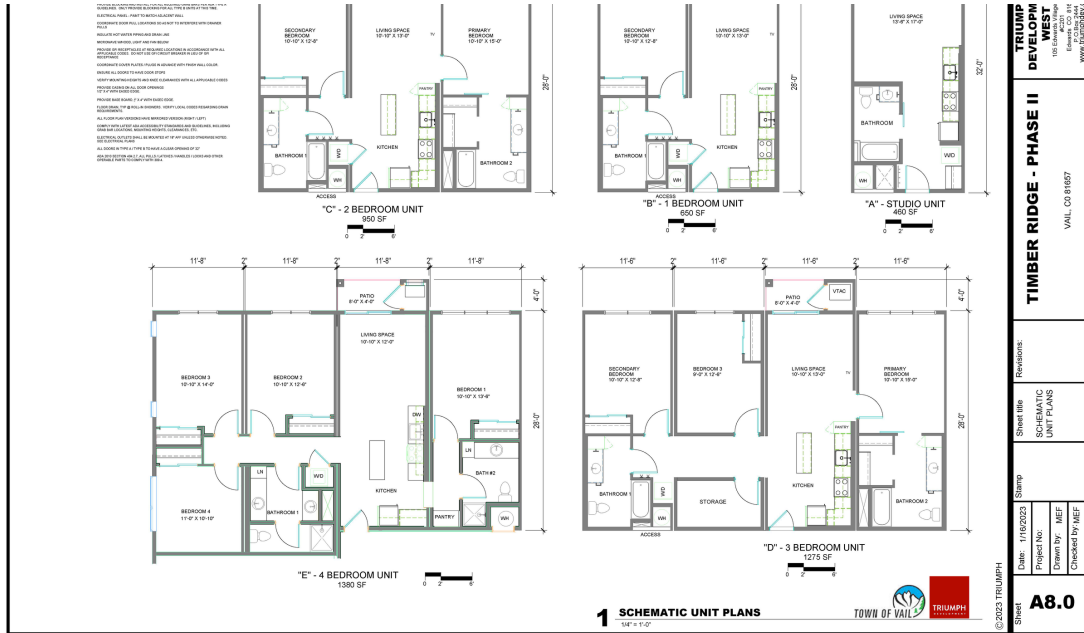

VAIL RECREATION DISTRICT DIRECTOR REPORTS

March 23, 2023

MARKETING

- We are working on ads and listings featuring our summer programs for print pieces including Bike & Hike Magazine, What to Do and Vail Valley Magazine.
- Check out the Vail Daily Summer Camp Guide, out now in newspaper stands - our print ad is on the inside back cover.
- We have a half page ad in the special "Summer" section of the Vail Daily which will be inserted into the paper on March 8, 15, 22 and 29. Additional copies are being distributed to hotel lobbies.
- We finished the Year in Review for 2022 – this year it is a web page rather than a printed piece: <https://www.vailrec.com/about-us/2022-year-in-review-home>.
- We have been helping Scott and Jared with a lengthy Dobson Programming document, which contains photos and descriptions of all the different elements inside and outside Dobson Arena. This will be shared with TOV and POPULOUS.
- Gearing up for golf season, we created new golf rack cards and golf passes & punch cards.
- We put out a press release announcing the new head coach for gymnastics, Sunny Hasebe. This ran in the Vail Daily on March 9.
- Madelyn created a great poster/flyer for the "Fantastic Gymnastics: Secrets of Tumbledore" Spring Show.
- Madelyn has gotten a good head start on the Trail Running Series t-shirt graphics! She is finishing up the poster for trail running and working on posters for mountain biking and whitewater.
- We have been promoting the last winter race, the Shamrock Shuffle on March 18, as well as the Easter Egg Hunt on April 8.
- We continue to promote, via print and digital mediums, the steady stream of winter/spring VRD offerings/events including the Nordic spring sale, youth sports camp registration, day camp registration, Imagination Station, Grill on the Gore, open gyms and more!

SPORTS

- Adult Sports:
 - Adult basketball draft league is underway, this is a new concept where individuals signed up and were drafted by team captains. We have five teams and so far the program is running smoothly.
 - Winter adult volleyball league wrapped up and a spring league will be starting soon.
 - Open gyms continue at Red Sandstone with basketball on Mondays and volleyball on Fridays.
- Youth Sports:
 - High Country Hoops is off to a good start with 30 kids participating in the 1st and 2nd grade program and 24 kids in the 3rd -5th grade program.
 - On deck will be spring T-ball and soccer starting the first week of May. Spring soccer already has 150 kids registered with a month for folks still to register.
- Events:
 - Bloch and Chapleau winter race have been going well.

- The Shamrock Shuffle on March 18 rounds out the winter race series.
- We have timed two of Beaver Creek's three races in their 2023 Snowshoe Series. The final race is March 26.
- We have been busy preparing for summer, our event and schedule is nearly set and are working on contracts with our land partners and renewing existing partnerships.
- Summer Field events and Sports Camps
 - Summer sports camp registration is open. All camps are tracking well. One camp, fall football already has a waitlist.
 - The field schedule is set, and contracts have been sent to organizers.

GOLF MAINTENANCE

Grooming: Nordic track and trail conditions have been excellent due to the 132 inches of snow received through November 9, 2022, to March 15, 2023 (4 months). This is slightly below the 30-year average (12 months) of 177 inches.

Greens: As of 3/15/2023 greens 1, 3, 5, 6, 7, 12, 13, 16, and 17 have been cleared and have no signs of ice damage or snow mold outbreaks. 16 green did show a slight very small ice patch. I believe the cause to be melting before the surface and snow froze.

Greens Construction: Total Turf Golf Services has been contacted and is ready to mobilize when weather conditions are favorable to complete our greens and bunker renovation project for the spring of 2023.

Magic Valley Turf Grass: Magic Valley has 50,000 square feet of Dominator Bentgrass secured and ready for delivery when weather conditions and soil temperatures are favorable for planting. During the 2022 season we planted our golf greens on May 19th.

Community Programming

- We are preparing and anticipating our April 1 Summer Camp registration opening.
 - Processing paperwork and scheduling our field trips/activities for Pre Kamp & Camp Vail.
- Imagination Station is still seeing steady participation and birthday party requests.
- Imagination Station's new laser light table has arrived and has been a great addition to our exhibit offerings.
- We have Schools Out Camp (SOC) on Friday, March 31.

NORDIC

- VNC will put soft goods and hard goods on sale up to 25% off beginning Monday 3/6.
- We continue to have a greeter/ pass checker on Friday, Saturday and Sundays checking for day passes and season passes. Pass holders appreciate that we are doing this.
- VNC hosted Red Sky Ranch on 3/2 for a ski group, lessons, and lunch in the restaurant.
- VNC hosted the Alpenrose Vail on 2/27 for a staff team building event for 45 employees and had a catered lunch in the banquet room. Great job by VNC staff and F&B department.
- VNC hosted Gravity House staff and members for a Nordic ski day and lunch in the Grill on the Gore
- Future groups 3/15 Walking Mountains, 3/28 Prima Vail Evening Snowshoe Tour.

- With all the snow and windy conditions, the Nordic, bike, and snowshoe trails are all in amazing shape. Kudos to the golf maintenance team for their grooming work on the Nordic track.
- Demo day was Saturday, March 11th, very good turnout and had a great day in retail sales.
- Remaining Nordic clinics are scheduled for 3/15 skate and 3/29 classic.
- Grill on the Gore has been doing a great job with soup buffet and service, rave reviews from patrons.

FOOD & BEVERAGE

Dobson:

- We are in our final month of Yeti games which have shown good attendance throughout the winter which in turn has resulted in solid F&B sales.
- We are continuing to work with Walking Mountains on our sustainability program during Yeti games which has been a great success. Once we finish our season they will compile all of the waste diversion numbers and I will put together a sheet to discuss the benefits of this program with real numbers.
- We hosted two large events that have been vacant from Dobson for several years and they came back this season:
 - The National Brotherhood of Skiers concert.
 - FTI Dinner and concert.
- We are looking forward to hosting Project Funway again this season in a few weeks.

Grill on the Gore:

- Continues to see increased revenue growth year-over-year.
- Guest service scores are continuing to stay high.
- We will remain open through the remainder of the Nordic season with a close date of April 9th.

Events:

- We are happy to welcome back Courtney from her maternity leave.
- We are continuing to see strong interest in events for both 2023 and 2024.
- We have had strong local bookings in the past month including:
 - Our local United Way's annual fundraising dinner for 100 people.
 - We hosted an employee party/Olympics for the Almresi and Alpenrose staff which combined a full day of Nordic activities and food & beverage for 40 people.

GYMNASTICS

- The Gymnastics Center has welcomed Sunny Hasabe as the new Head Coach. Sunny will coach all classes and levels including girls and boys recreational, tumble and trampoline and all levels of our Junior Olympic competitive team.
- Level 9, Ava Knight finished 2nd on the uneven bars with a 9.225 and 4th overall at the Gasparilla Classic in St. Petersburg FL February 25.
- Vail Gymnastics will host a wizard themed spring showcase called **Fantastic Gymnastics: The Secrets of Tumbledore** on Saturday, April 8 at 1:00pm. Recreational and competitive participants will perform skills they have been perfecting all season for family and friends.
- The Level 7 – Level 9 Team will head to the Colorado State Championships March 25 & 26. Athletes have the opportunity to qualify to the Regional Championships where they will compete against the top gymnasts from Colorado, Texas, Kansas, Arkansas, New Mexico, Wyoming and Oklahoma.

- Registration for our week-long summer recreational gymnastics camps opened on March 1. All five weeks are full (some filling within 24 hours) and waitlists exceed 30+.

GOLF

- Staff is continuing to actively recruit summer golf staff.

- First Tee-Colorado Rocky Mountains registration opened in Mid-February and currently has about 60 percent of available spots reserved. More will open as the camps get closer.
