A Regular Meeting of the Board of Directors of the Vail Recreation District, Town of Vail, Eagle County, Colorado, was held on April 14, 2016 at 5:00 p.m. at the Vail Town Council Chambers, Town of Vail, Eagle County, Colorado, in accordance with the applicable statutes of the State of Colorado.

6. CALL TO ORDER

6.1. Director Suarez called the meeting to order at 5:00 p.m.

7. APPROVAL OF MEETING MINUTES

7.1. By motion duly made and seconded it was RESOLVED to approve the minutes of the March 24, 2016 meeting, with Director Newbury abstaining due to her absence from the previous meeting.

8. PUBLIC INPUT OF ITEMS NOT ON THE AGENDA

- 8.1. Mr. Rodney Johnson introduced himself and stated that he is running for the VRD Board of Directors.
 - 8.1.1. Director Suarez asked if there was a nice celebration of life for Mr. Thomas Ruikka and if there would be another celebration this summer.

- 8.1.2. Mr. Johnson confirmed that there would be another celebration in June, aiming for June 20, Mr. Ruikka's birthday.
- 8.1.3. Director Newbury wished Mr. Johnson good luck in the election.

9. RECOGNITION FOR OUTSTANDING PERFORMANCE BY OPTIONAL GYMNASTICS TEAM 2016

- 9.1.1. Ms. Julie Cotter, director of the Vail Gymnastics Center, and Ms. Maryann Oehlerking, head coach at the Vail Gymnastics Center, presented the Level 7 and 8 Vail Gymnastics Center team to the Board and talked about how the team members have set a number of records for the Vail Gymnastics Center and brought home a number of state championships this year.
- 9.1.2. Mr. Ortiz thanked the girls for their commitment and for representing Vail so well in and out of the gym, and the coaches for their hard work.
- 9.1.3. Director Foley asked if there was a meet this weekend.
- 9.1.4. Mr. Ortiz responded that the regional meet will be taking place in Arkansas.
- 9.1.5. Ms. Cotter explained that the Vail Gymnastics Center spring show will also be occurring this weekend showcasing recreational and team gymnasts.
- 9.1.6. Rob Page, a gymnastics parent, thanked the Board and staff for everything that the Vail Gymnastics Center has been able to accomplish over the past few years and thanked the Board for keeping the gymnastics center program going.

10. GORE RANGE ROOM PRICING 2016-17

10.1. Mr. Scott O'Connell presented proposed pricing for the exclusive use of the banquet space at the Vail Golf & Nordic Clubhouse, now being referred to as the Gore Range Room. The VRD is prepared to take bookings for events seven days a week, year-round, starting in October 2016 with different options for multiple-hour blocks for weddings, social and corporate events. After some discussion, the Board thanked Mr. O'Connell for his work in putting this pricing together.

11. REVIEW GOLF COURSE DONATION APPLICATIONS

- 11.1. Mr. Ortiz stated that he and Ms. Alice Plain, director of the Vail Golf Club, met with Director Wiles and Director Saalfeld and after some consideration, the group decided to give the donation to the Battle Mountain Touchdown Club. This is the first time the Touchdown Club has asked for a donation, although they have rented the golf club multiple times in the past, and they have a history of running successful events. They also bring in soldiers from Ft. Carson for their events, and have hosted 40 military families over nine years.
- 11.2. Upon a motion duly made and seconded it was unanimously approved to

- donate the Vail Golf Club to the Battle Mountain Touchdown Club for a one-day golf course buyout this season.
- 11.3. Director Newbury addressed the two other donation requestors and recommended that they reapply next year for consideration.

12. EXECUTIVE DIRECTOR INPUT

- 12.1. Mr. Ortiz stated that as of last week, all greens were cleared and re-treated with a fungicide for snowmold suppression, and they continue to look healthy.
- 12.2. In sports, Mr. Ortiz shared that 170 kids signed up for youth soccer, which is up about 20 kids from last season. The VRD has six under-8 teams, four under-10 teams and 65 kids in micro soccer.
- 12.3. Mr. Ortiz stated that on a personal note, Mrs. Beth Pappas's team raised \$6,500 for Pink Vail and Mr. Joel Rabinowitz's U11 boys' soccer team raised \$1,500. Mr. Ortiz gave kudos to those two employees for their fundraising efforts.
- 12.4. Mr. Ortiz stated that Mr. Joel Rabinowitz met with the Vail Valley Partnership and the Town of Vail regarding visiting international teams, a Japanese youth baseball team and a German pro soccer, that are coming to Vail and the fields this summer.
- 12.5. Mrs. Jessie Klehfoth talked about the new VRD website and registration system that launched last week, and stated that the response to the website has been very positive. The VRD saw over 125 individual orders placed the first week and the website saw a 57% increase in visits over last year, along with other healthy website statistics.
- 12.6. Mr. Ortiz stated that Mrs. Klehfoth posted photos on Facebook from the Shamrock Shuffle, and Mrs. Klehfoth put together a video from the Easter Egg Hunt, featuring a GoPro point-of-view experience of one of the 5-year-old participants that he recommended the Board watch if they haven't already.
- 12.7. Mr. Ortiz mentioned that FBLA is currently using the Dobson Ice Arena for their event, followed by two Hispanic dances before the facility will shut down for a maintenance period.
- 12.8. Mr. Ortiz spoke about how Mr. Chad Young and Mr. Christian Kloser put together a Nordic obstacle course the week of 4/6-7 with the PwrHrs kids. This was a very successful program in its first year.
- 12.9. Mr. Ortiz gave kudos to the Community Programming department for the successful Easter Egg Hunt.
- 12.10. Mr. Ortiz mentioned how Community Programming has been working hard on updating the VRD website and new registration database, and Mr. Ortiz commended the staff of all the departments involved for their hard to get everything ready for the opening day of registration. He also specifically commended Mr. Joel Rabinowitz for managing the registration project overall and Mrs. Jessie Klehfoth for the new website. Also Mrs. April Heredia was

commended for setting up the financial side of the registration system.

- 12.11. Mr. Ortiz stated that the Green Elephant Juicery is a new sponsor of the Vail Gymnastics Center spring show, and thanked them for their support. He also stated that parking for the show will be limited at the Gymnastics Center, and thanked Mr. Bugby and Sun Vail for allowing guests to park there during the show on Saturday.
- 12.12. Mr. Ortiz commended the boy's competitive gymnastics team who will be competing in the upcoming Region 3 championship.
- 12.13. Mr. Ortiz finished by stating that the town council will be touring the clubhouse construction site on May 3.

13. BOARD MEMBER INPUT

- 13.1. Director Newbury invited the Vail Valley Foundation (VVF) to speak to the VRD Board regarding the proposed music festival and the impact that it would have on users and the recreational facilities, and encourages the public to attend that presentation and provide input.
- 13.2. Director Foley seconded the request for the VVF to present to the Board and ensure that there will be no negative impact on the condition of the athletic fields by the festival.
- 13.3. Mr. Ortiz explained that there are still many questions that need to be answered regarding the impact and the timing of the festival, including the downtime before and after the event.
- 13.4. Director Newbury stated that she has heard the VVF's presentation to other entities and wants to ensure that the VRD Board represent the interests of the VRD constituents and users throughout this exploratory process.
- 13.5. Director Foley asked how the softball league signup went at Sports Authority.
- 13.6. Mr. Ortiz stated that signup went well and that tonight is the uniform pickup for youth soccer.
- 13.7. Director Foley also asked about election information.
- 13.8. Mrs. April Heredia explained that absentee ballots have been mailed out to all who requested them and that VRD will continue to take absentee ballot requests through April 29th. Requests can be made at the Tennis Center at 700 S Frontage Rd E in Vail.
- 13.9. Director Suarez stated that he saw the recreational path at the Vail Golf Club has been cleared. He also said the golf club conditions are looking great, as are the tennis courts. He also wanted to thank the gymnastics team for coming in, and stated that the Town of Vail did a great job with the film festival and the Taste of Vail events.

VAIL RECREATION DISTRICT DIRECTOR REPORTS May 12, 2016

GOLF MAINTENANCE

- Golf course will open on May 15th, all 18 holes, with no carts, walking and golf bikes only. Still some snow on the left sides of 5 and 14, and a few other pockets here and there that shouldn't effect play much.
- Course is in excellent condition coming out of the winter, so the abbreviated preparation time leading to opening will be offset some by minimal winter damage.
- Last week we put 2 mowing's on greens, tees, and fairways, and did a lot of cleanup of debris, and an initial cleaning of the sand traps.
- Irrigation was charged up last week, with exception of areas on the range and practice greens complex that need irrigation repairs.
- Staffing-Had 10 or so come on board May 2nd. Now, on May 9th we have 17 seasonal staff hired, with 13 full time and 4 part time staff.
- Contractor began prepping for sodding of the storm water line installed last fall on 10 fairway. After that, they will work on the driving range tee and floor areas of disturbance, and then move on to the practice/chipping green area.
- With the continuation of winter weather, our projections for water supply this summer are good going into the season, but as always, early summer weather will determine whether we have a quick melt and runoff with potential for flooding, or, a nice moderate melt and runoff without flooding and/or water supply issues.
- As a result of the wet weather, and healthy turf on the greens, we have not had
 to utilize our protective covers on the greens this spring for the first time in my
 tenure here.
- Projects in progress, or soon to be started:
 - o Tee box re-leveling, year 3 of phased plan, on 14 and several other holes.
 - o Cart path asphalting on holes 1, 9, and 12, and possibly others.
 - Leveling of the range tee mat stations, once contractor completed repairs.
 - Staining of wooden bridges and other wood components and facilities.
- Snowpack and water-equivalent figures as of 5-9-16:
 - Snow-water equivalent for Upper Colorado River basin is at 110%.
 - Snowpack is at 99% for the Upper Colorado basin.

GOLF OPERATIONS

- The pro shop in the modular is coming together. It now looks like a golf shop! George Hart, Nate and I have worked two weeks on setting it up. We still have a bit of work to do this upcoming week.
- Staff attended the annual spring PGA West Chapter Meeting in Grand Junction at Book Cliff CC. Alice accepted her Horton Smith Award.
- We have been selling golf passes via phone and walk in's since May 2nd. We are also offering pass sales online through the Vail Recreation District website as

- well. The discount for early purchase this year is prior to June 1st. After this date, golf passes will increase in price by \$50.
- We plan to open the golf course on May 15th with 18 holes. The course will be "walking only" until June 2nd when the new golf car fleet arrives. We will have freshly tuned golf bikes available and rental push carts available.
- Our PGA PGM Interns will start arriving between May 15th and May 20th. We have five PGM Interns joining us this summer. The college students will be here from Campbell University in North Carolina, Coastal Carolina, UNLV, and Sam Houston in Texas.
- Nathan Mead is our Head Professional for the 2016 season and George Hart is our First Assistant. They are both PGA Professionals.
- The Battle Mountain Football fundraising tournament in conjunction with the Fort Carson soldiers is scheduled for Friday, June 10th. This is the tournament selected by the VRD Board for the golf course donation.
- Our group lesson programs during the early season this year will be affected by the driving range renovation. We plan to offer Men's League the first Wednesday of June, however, we will not have a driving range at this time.
- The Vail Valley golf professionals continue to collaborate on the new PGA Junior League taking place in the valley this season for children ages 8-13 years. This program will begin in June. Dave Rawlings, PGA professional will be coaching the Vail Team.

SPORTS REPORT

- Sports is busy.
- First two short track races went well. The first at 4 Eagle Ranch was during Eagle County Schools spring break and not as well attended (45 participants), but the second one at the Eagle had 87 participants. The final short Track race is this week (5/11) at the Miller Ranch Open Space.
- The MTB Series will kick off on May 25 with the Eagle Ranch Classic.
 Registration for the series is underway and the new online registration system has significantly streamlined the process.
- Whitewater Series starts tomorrow (5/10).
- First trail run of the series, the Boneyard Boogie, is Saturday (5/14) in Eagle.
- Sports is always looking for volunteers for events and welcome board member participation.
- Working with the Mattison's and Vail Resorts on a new Expert course for the Kids Adventure Games. The new course will utilize Gondola One.
- Sponsors: Optic Nerve returns as a supporting sponsor for TR, MTB and WW.
 Larkburger returns as the title sponsor of the Youth MTB Series and will host bib pickup for kids at the Larkburger location in Edwards on May 24. Summit Ford has transferred their sponsorship from MTB to the 10@10 and Winter Hill Climb this year. While Sports Authority committed to sponsorship again this year, they are in bankruptcy proceeding and selling assets so don't anticipate seeing the financial contribution that was agreed upon. We continue to renew existing sponsors and acquire new ones.
- Held an event staff orientation for high school kids.
- Working with Kirk and Summit Ford to buy an additional truck for the sports department.

- Adult Softball is full on all 3 nights with 41 total teams starting the first week in June
- Adult Cornhole and Sand Volleyball leagues are open for registration

MARKETING

- The new VRD website continues to perform very well with April users up 12% YOY, sessions up 21% and bounce rate down 5%. We had over 381 individual online orders in the first month, and we also booked over 2,482 days of day camp through Max Galaxy in the first month of registration.
- Press releases and emails were sent out for the trail running race series, whitewater series, May programming overview, short track race series, golf club passes on sale and opening information, Vail Invitational Soccer Tournament, weekly gymnastics updates and more.
- Photos were posted on Facebook, Instagram and the website from the first two short track bike series races and a comprehensive social media marketing plan is currently in place for all race series, which has been very successful in driving engagement and participation so far.
- The VRD was featured numerous times in the Vail Daily recently including three front page photos over the past week. Coverage included information and results from the election, mountain bike series, trail running series, whitewater series, softball signup, tennis court construction, and golf club opening dates and pass sales announcements, plus daily calendar events and a few Town Talk and "Top 2" events mentions as well. Jessie and Beth continue their weekly chat on Tuesday morning on air at KZYR. Daily ads are running on local radio stations and ads in the paper are running every other day.
- Working with Jason Roberts with Intercept Insights to plan out summer research.
- Summer marketing is in full swing with comprehensive media plans for all departments and major activities targeting locals, Front Range and destination visitors when appropriate.
