10. 2018 MEETING DATES

Vail Recreation District January 11, 2018 Meeting Minutes

- 10.1. Mr. Weaver said the first meeting of the year is used to set the Board of Directors meeting dates and designate the posting locations. The Board is scheduled to meet the second and fourth Thursday of every month, except the fourth Thursdays of November and December, due to the holidays.
- 10.2. Director Foley asked if a date could be set for the Board retreat. Mr. Ortiz will look into potential dates.
- 10.3. By motion duly made and seconded it was unanimously RESOLVED to approve the 2018 meeting schedule as presented.

11. 2018 MEETING NOTICE POSTING LOCATIONS

- 11.1. Mr. Weaver stated that Colorado law requires that meeting notices be posted in three locations. Those three locations are currently the Town of Vail Municipal Building, the Vail Golf & Nordic Clubhouse and the Vail Recreation District Administration Office. The VRD also does a courtesy fourth post at the Dobson Ice Arena.
- 11.2. By motion duly made and seconded it was unanimously RESOLVED to approve the 2018 meeting notice posting locations as presented.

12. INTRODUCTION OF NEW FOOD AND BEVERAGE EMPLOYEES

12.1. Mr. Scott O'Connell, VRD Director of Operations and Facilities introduced some new members of the VRD food and beverage department. Bernie McManus is the new restaurant and banquet manager for the Vail Recreation District, and Carolyn Israel is the new group sales manager. The Board welcomed them to the VRD.

13. PICKLEBALL MASTER PLANNING COMMITTEE

13.1. Mr. Ortiz asked for two members of the Board to serve on a new pickleball master planning committee due to the rapid growth of the sport in Vail. He stated the sport is very popular with locals and guests, and he wants to be looking ahead and planning for the future of the sport in Vail. The committee would be charged with getting input on new locations for play, pricing, and working with the Town. Directors Saalfeld and Foley volunteered to serve on the committee.

14. UPDATE ON NORDIC OPERATIONS

14.1. Mr. Dan Timm, VRD Nordic Center Director, gave a presentation to the Board on happenings at the Vail Nordic Center. He stated the Nordic Center is open daily from 9 a.m. to 5 p.m. and offers 10K of snowshoe track, 17K of classic and skate ski track and, new for 2018, 13K of fat-tire bike track. The Nordic Center offers a fully-stocked pro shop, which has seen excellent sales of hard and soft goods. Mr. Timm said that rentals of skis, snowshoes and bikes have been strong, and they've averaged two to six lessons per day. He

also said over 600 season passes have been distributed. Guests have been enjoying the Grill on the Gore restaurant and high service and food quality, where a soup buffet is served every day from 10:30 a.m. to 2:30 p.m. and an expanded menu is served Friday through Sunday until 6:30 p.m. Mr. Timm talked about a successful first town series race on Dec. 27 that drew a large attendance at over 90 racers, and featured an after-party in the Grill on the Gore. He also spoke about upcoming events including a Demo Day on Sat, Jan. 13 and the first race in the Vail Grail Winter Race Series, a citizens 5K skate, on Jan. 20 in conjunction with the Battle Mountain High School home invitational.

15. UPDATE ON IMAGINATION STATION

15.1. Mr. Chad Young, VRD Community Programming Director, gave a presentation about the Imagination Station. Located on the second floor of the Lionshead Welcome Center, and open 9 a.m. to 5 p.m. Sunday through Tuesday and until 8 p.m. Wednesday through Saturday, the Imagination Station offer activities for all ages. Mr. Young talked about the different features of the educational play area, including a Thoughts Flow water table, play wall, hyperbolic funnel, light table and builder boards, and pretend veterinarian and baby clinic. New this year, Mr. Young and staff have added a rotating schedule of art and science projects for children, in addition to daily paint your own pottery and art studio offerings. Mr. Young also spoke about the new virtual reality experience at the Imagination Station where kids and adults can engage in active and creative virtual adventures like playing Fruit Ninja and painting in three dimensions. Mr. Young said the Imagination Station continues to host a semi-monthly adult art series called Cocktails & Canvas and is available for private parties.

16. AFFIRM RECREATION SUBCOMMITTEE MEMBERS

16.1. Mr. Ortiz stated a desire to convene the Recreation Subcommittee with the Vail Town Council on the day of the first council meeting in February. In 2017, Directors Saalfeld and Suarez served on the committee for the VRD. Both directors volunteered to serve on the committee again for 2018, with Director Newbury Rediker offering to sit in for Director Suarez if he's unable to attend the first meeting. The purpose of the committee is to discuss many different topics, ranging from town planning of facilities, parking, pickleball, events and more.

17. EXECUTIVE DIRECTOR INPUT

17.1. Mr. Ortiz talked about Ms. Alice Plain and staff going to the PGA Merchandise Show in Orlando the week of January 22. Ms. Plain is also writing an article for the PGA Magazine on merchandising.

- 17.2. Mr. Ortiz said the golf maintenance staff is working on their recertification Audubon International toward the Cooperative Sanctuary status. They have also been helping with Nordic track grooming.
- 17.3. The sports department recently produced a Holiday Sweater Run with Vail Holidays and a contingent of the gymnastics team even participated.
- 17.4. Mr. Ortiz said the first race of the Vail Grail Winter Race Series is Jan. 20, a 5K Nordic Citizens Race at noon at the Vail Nordic Center. They are looking for help with parking and timing if members of the community would like to volunteer.
- 17.5. Mr. Ortiz said there were 1200 people at the most recent Vail Yeti game at Dobson Ice Arena, and there will be games again this weekend. He said the skating show also had about 400 people in attendance each night.
- 17.6. Mr. Ortiz talked about projects the marketing department is working on, including the summer brochure, year in review, Vail Daily ads and more.
- 17.7. Mr. Ortiz reiterated that the Vail Nordic Center hosted a Town Race Series event on Dec. 27 with 90 racers.
- 17.8. Mr. Ortiz mentioned that the Vail Gymnastics Center competitive team has their first meet of the season this weekend in Denver. They also had camps over the holiday breaks with over 70 kids.
- 17.9. Gymnastics has also hired a new assistant coach, Allyson Pancott, who is a former Level 10 gymnast and whose parents own a gym in Pennsylvania.
- 17.10. Finally, Mr. Ortiz wished Director Foley a happy birthday.
- 17.11. Mr. Ortiz thanked Mr. Greg Clifton, Vail Town Manager, for hiring an owner's rep for clubhouse construction to hold contractors in check.

18. BOARD MEMBER INPUT

- 18.1. Director Foley asked about the Vail Yeti games and security. Mr. Ortiz stated that security has been increased this year to help with crowd control and Director Newbury Rediker stated that she attended the game on Friday and said the crowd was well behaved and security presence was noticed.
- 18.2. Director Saalfeld thanked Director Suarez for calling in and sent him best wishes for a speedy recovery.

VAIL RECREATION DISTRICT DIRECTOR REPORTS

January 25, 2018

GOLF

- Alice is heading to the PGA Show next week. She has several meetings set up
 including an interview with a former PGM intern from two years ago to come back
 to the Vail Golf Club as a full PGA golf professional.
- The Nordic center has been quite busy! The lack of snow has spurred business here at Nordic. We continue to sell Nordic season passes and have heard positive feedback on the customer service and helpful staff at the Nordic Center.
- We continue to book corporate groups including shotgun events for spring and fall of this season. Currently we have three shotguns in June scheduled and a tentative event in September, in addition to the High Fives (not scheduled) and the BBB (not scheduled).
- Met with Molly Eppard from the Town of Vail for the artwork in the new clubhouse. We have been able to track down three Ford posters and several black and white photographs from the Ford tournament. We have reserved several spaces on walls for these photos. I am excited to showcase the Vail Golf Club history in our new facility!

GOLF MAINTENANCE

- The grooming of Nordic trails has alternated between being done with the new Prinoth snowcat and our tracked utility vehicle and ginzu groomer. The new snowcat has been able to groom following some of our better snow events but has been parked on other days due to the continued lack of snow and base depth.
- Current settled snow depth at our measuring station next to 3 green is 16", up 8" from the reading two weeks ago.
- Storm forecasted this Saturday/Sunday is calling for 4-10". If we receive something toward the higher end of that range we may be able to permanently groom with the snowcat.
- Items that golf course maintenance staff is working on this winter for next season:
 - Acquisition of new equipment: placed purchase order for a new hybridpowered fairway mower, a new rough mower, two new walk tee mowers, as well as a tire-mounting machine for equipment manager Kirk Hower.
 - Recertification with Audubon International toward our Cooperative Sanctuary status. We recertify every two years to maintain our status that the club first achieved in 1994.
 - We are studying beginner Spanish through an online program from Rosetta Stone so that we can reach out to an additional pool of applicants for next golf season that we have not been able to attract in the last several years.
 - Scott and Justin will be attending the annual Golf Industry Show, with seminars and trade show on the week of February 5.
 - Webinars and seminars on agronomics and management topics.

SPORTS REPORT

- Partnered with BMHS to produce a Nordic high school, middle school and citizens race at the Nordic Center. Thanks to VMS and the Town of Vail for their parking support. The citizens race is the first in a four-race winter series, the Vail Grail.
- Winter adult and youth sports leagues started with adult basketball league (eight teams), adult volleyball league (12 teams), and youth futsal (significant increase in participants over 2017).
- Adult open gyms continue to be busy at RSES. Schedule is as follows: Basketball – Monday, Indoor Soccer – Tuesday, Volleyball – Friday and Pickleball – Thursday, Saturday, Sunday
- Upcoming races in the Vail Grail series are:
 - o Feb. 10 Vail Derail fat bike race at the Nordic Center 4 p.m.
 - Feb. 18 Winter Uphill on Vail Mountain 7 a.m.
 - March 17 Krueger Family Shamrock Shuffle at the Nordic Center 4 p.m.
- We are nearly set with a summer schedule including races, tournaments, leagues and camps.
- Had an initial meeting with Vail Valley Foundation on an expanded role with the GoPro Mountain Games, we are exploring and contemplating some options.
- Met with Town of Eagle regarding our help in producing the Eagle Outside Festival.
- Met with the Town of Minturn who have allocated funding for the MeadowGold trail run and the youth mountain bike kickoff race.
- Met with the US Forest Service on their initial feedback on some new ideas for races. We will be submitting our permit shortly.
- Beth will be attending Outdoor Retailer at the end of the month to meet with existing and potential partners for the race series.

DOBSON

- We had 815 people attend the Yeti game on Jan. 13. The Yeti have been growing in popularity as time goes on. They are currently averaging 800 people a game.
- Learn to Skate started back up with Session 2. We have 40 skaters registered. Theater on Ice has 18 skaters registered. Jr. Prep Jumps and Spins has 14.
- Adult League also started back up with the 12-game winter season. We have four A division teams, five B Division and seven C Division, which is by far our largest winter adult league ever. We have usually maxed out around 13 in the past. We worked out the ice times this year to help us maximize our leagues. The only ice slot left during the week is 11 p.m. on Wednesday.

MARKETING

- Marketing is putting together the VRD Year in Review with assistance from all directors and will have it ready for distribution at the annual town community meeting in March.
- Marketing is also working on the new "everything VRD" summer guide and will begin distribution March 1.
- Marketing continues regular KZYR, Vail Daily and Vail Daily Weekly ads and will also be featured prominently in the upcoming Vail Daily Olympics section.

- Jessie continues her review of the VRD website and cleaning up pages and adding photos and content. She is also reviewing and updating all digital listings on Trip Advisor, Yelp and mapping sites.
- Marketing is working on a new Whitewater Race Series logo, new whitewater race jerseys for athletes to wear, gift cards for the Vail Golf Club/Nordic Center, a new rack card for the Imagination Station, Cocktails and Canvas promotions, Facebook advertising, an updated wedding brochure, and a number of other projects.

PARKS

- Nordic Center has been doing well, track is holding up and conditions have been very good.
- Sales of hard goods and soft goods have been very steady.
- Rentals (skis, snowshoes and bikes) have been very busy.
- Pass sales have exceeded 600 season passes and are still going strong.
- Guests have really enjoyed having the restaurant open, great food and service.
- High school and middle school race scheduled for Jan. 20 has 436 registered racers.
- First race in Vail Grail Series (5K Nordic race) is also scheduled for Jan. 20.

GYMNASTICS

- A Backhandpsring Day Camp was offered on January 3, which hosted 25 gymnasts both recreational and competitive. Gymnasts learned new tumbling elements in a full day camp.
- Anna Bumgardner, level 7 placed first in the uneven bars at our first competition at Gymnastics Unlimited last weekend. Riley Bellm took second place overall in her respective age group as a level 8.
- Vail Gymnastics team will travel to Boulder for their second competition on January 20. The next two competitions will take place at the Broadmoor in Colorado Springs followed by our largest competition of the season in Las Vegas.
- We have welcomed a new assistant coach, Allyson Pancott who will be working with all programs from toddlers through to the competitive program. We are excited to have Allyson join our team!

Vail Golf & Nordic Clubhouse Construction

- TOV conducted 1-year warranty punch walk, several cosmetic issues were identified as well as one leak, possibly from hydronic snow melt on mechanical deck. Leak was visible in the upstairs catering kitchen.
- Climate Control has been on-site to resolve HVAC issues, TOV has hired a second HVAC company to verify that all HVAC items listed in the commissioning report are corrected.

- Commissioning agent will be back to test and provide feedback to corrected items.
- Phase 2 of interior sign package is installed. Working on track signage enhancements based on feedback from track guests and staff.
- CO₂ alarm in mechanical room still an issue, will follow up with Climate Control and Evans/Chaffee to resolve.
- Lightning detection system now mounted on building, however needed "plan B" to install due to issues found with construction not meeting plans. Additional modifications required.

F&B

- Weekend business has been steady but not yet busy. Midweek business through first two weeks of January has been consistent to 2017 but soft.
- Saw strong sales over the holidays.
- Hosted high school race and saw happy athletes and parents.
- Summer bookings look very strong, all Saturdays from June through mid-October are booked.
- Yeti hockey F&B revenue has been strong and shown growth year over year.
- Prepping for large events at Dobson, Operation Altitude (375 people), Project Funway (approx. 400), Burton after-party (2000).

Golf Maintenance

- Working with architect and local engineer to prepare construction plans for replacing west garage door to accommodate snowcat parking, coordinated effort with TOV.
- Plans progressing for civil parking lot work.

Community Programming

Traffic in Imagination Station has slowed to 4-10 families per day. Still, families
are staying longer, coming back more often and (sometimes) spending more
during their visits to Imagination Station. People love the space and appreciate
our service. "Imagination Station made our visit great," said one mother of four
from age 2 to 10. "There was something for every age." Virtual reality is getting

some business and revenue; Paint Your Own Pottery continues to be popular with visitors. We need to continue to market virtual reality, it has great potential as a revenue stream along with the art options. We also need to continue to market our evening hours from Wednesday through Saturday. We are open 7 days per week: open every morning at 9 a.m., and close at 5 p.m. on Sun-Tue and open until 8 p.m. on Wed-Sat.

- The fourth Cocktails & Canvas of the winter season on Thursday, Jan. 18 was canceled due to lack of registrations. This class was produced by Lauren with Alpine Arts Center who was renting the room from VRD. While we want to see this partnership and her classes succeed, this was her class to market and sell.
- A family has hired us to host 40 children at Imagination Station the night of Saturday, Jan. 20 from 6 to 10 p.m. We will offer pottery, virtual reality, and all the other activities at Imagination Station; we'll wrap up the night with a movie about 8:30 or 9 p.m.

Summer Camps

 We have approval from Golden Peak Children's Center to host PreKamp, Camp Eco Fun and Camp Vail in this space. Meanwhile, I am working with state licensing to prepare ourselves for the process of moving KidZone/Camp Vail three times in one year: from Red Sandstone to Golden Peak, from Golden Peak to Maloit Park, then from Maloit Park to Red Sandstone. Each of these moves will require opening a brand-new license in a new location.

KidZone

- We hosted one day of School's Out Camp on Monday, Jan. 15. We have another camp on Monday, Jan. 29. These camps tend to have about 20 children.
- PwrHrs will resume Jan. 24; we are thankful for the new snow and we look forward to getting the children Nordic skiing Wednesday and Thursday afternoons.
- Chad toured the Maloit Park campus with Marcie, VSSA and the construction crew. Chad then toured with Mike and the licensing inspector to make sure we are prepared for our many moves this upcoming year. We have excellent cooperation from VSSA; we will see how receptive SSCV is to our requests.

PICKLEBALL

- Jerry is making plans for the Second Annual Vail Western Slope Regional Tournament and is considering a five-day event in August 2018.
- US Open and Tournament of Champions Gold Medalists, Ben John and Christine McGrath, conducted two clinics at Red Sandstone Elementary School with 24 participants on January 13.
- So far 51 2017/18 winter season (Oct. 1-May 31) and annual pickleball passes (Oct. 1-Sept. 30) have been purchased. 57 players purchased 2016/17 annual and winter passes last year.
- Drop-in pickleball play at Red Sandstone Elementary School is organized and supervised by VRD pickleball staff on Thursday evenings and Saturday and Sunday mornings. So far this year, indoor drop-in pickleball at Red Sandstone Elementary School has had an average of 35 participants per session.
