Mr. Sarro stated as far as the flooding, the water has gone down over the last 12 hours but we have been sand-bagging threatened areas and there is water coming through the parking lot and driving range to prevent additional flooding in the clubhouse.

The 7th tee is moving along, there is a large unexpected boulder that the wall now will need to be built around, however the project should be substantially complete by July 1st. Asphalt is being put down on Monday or Tuesday for the approaches to both bridges and landscaping will follow by the end of June. Lastly, the lightning shelter on hole #11 is complete and landscaping in the area will be performed in the coming weeks..
