## Minutes of the Regular Meeting Of the Board of Directors

# Vail Park and Recreation District dba Vail Recreation District July 14, 2016

A Regular Meeting of the Board of Directors of the Vail Recreation District, Town of Vail, Eagle County, Colorado, was held on July 14, 2016 at 5:00 p.m. at the Vail Town Council Chambers, Town of Vail, Eagle County, Colorado, in accordance with the applicable statutes of the State of Colorado.

## 6. CALL TO ORDER

- 6.1. Director Saalfeld called the meeting to order at 5:05 p.m.
- 6.2. Director Bill Suarez arrived at 5:10 p.m.

## 7. APPROVAL OF MEETING MINUTES

7.1. By motion duly made and seconded it was unanimously RESOLVED to approve the minutes of the June 23, 2016 meeting.

## 8. PUBLIC INPUT OF ITEMS NOT ON THE AGENDA

- 8.1. Rick Sackbauer wanted to compliment Bob Seward, Mike Ortiz and Jerry Stevens for the great work getting pickle ball in Vail. He shared that Pickleball was an up and coming sport and that is growing here down to Gypsum. He is very pleased with the progress and the courts and availability here in Vail.
- 8.2. Mr. Sackbauer also wanted to ask that a VRD taxpayer discount and dedicated availability be built in to the new Golf Course Clubhouse. He wanted to make sure that it is available to those paying taxes.

8.3. Kay Ferry took her own survey of the number of vehicles and pedestrians that are on Vail Valley Drive. Her findings where that it is a very busy street. She shared her concern that she saw many Vail Recreation District vehicles or machinery from Vail Golf Maintenance on the road. She would like to know if the ordinance had changed and wanted to inform the board that the VRD vehicles should stay on the golf course and use the road as little as possible.

#### 9. VAIL GOLF CLUB MANAGED PARKING POLICY

- 9.1. Mr. Scott O'Connell developed the parking policy to help with the parking challenges that may arise during construction. Both Mike Ortiz and Scott O'Connell consulted with attorneys and our insurance carrier before implementing the policy. Mr. Ortiz gave an overview of how it would work. It was explained that this was "managed parking" not valet parking.
- 9.2. Director Suarez asked that when construction was completed the north part of the lot would open up and provide more parking. Mr. Ortiz confirmed that and stated that when everything was complete the new lot would provide 127 spots as opposed to our old lot that offered 104.
- 9.3. To date parking has been a non-issue.

## 10. VAIL GOLF CLUB CONSTRUCTION UPDATE

10.1. Mr. Scott O'Connell gave a presentation on construction at the Vail Golf Club, including the improvements to hole 10 fairway, the driving range, practice area and parking lot, plus an update on the clubhouse construction. After some discussion, the Board thanked Mr. O'Connell for his work on these projects.

## 11. VAIL GOLF CLUB EVENT FEE SCHEDULE

- 11.1. Mr. Scott O'Connell explained how he compared our pricing to various valley locations.
- 11.2. Mr. Mike Ortiz encouraged the board to do a thorough review of the fees.
- 11.3. Director Foely suggested that we offer a discount this fall and winter and implement full pricing with the start of the new season.
- 11.4. Discussion was held on various options that should be offered to VRD taxpayers and the discounts and hold dates that they should be offered to them.
- 11.5. By motion duly made and seconded it was unanimously RESOLVED to approve the Gore Range pricing with a change of offering a 15% discount to VRD taxpayers.

## 12. EXECUTIVE DIRECTOR INPUT

## Vail Recreation District July 14, 2016 Meeting Minutes

- 12.1. Mr. Ortiz asked the board if they had any questions on the report that was included in the Board packet. Director Foley wanted to just comment that he was excited to hear the Weather Channel was going to be present at this years Kids Adventure Games.
- 12.2. Director Foley also asked about the Adopt a Trail program and wanted clarification on a department head that had offered to pay for those who could not volunteer their time. Mr. Ortiz stated that no pay was needed as we had plenty of volunteers at our first outing and that it will be put out to the public for volunteers on our next outing, which will happen later this year.
- 12.3. Mr. Ortiz wanted to recognize Alice and all of her staff for the great job they are doing this summer. It is quite the process to start and finish a day with moving golf carts and accommodating our guest through the construction. They are all working very hard this summer to make it a great experience for our guests.

## 13. BOARD MEMBER INPUT

- 13.1. Director Foley wanted to share that he has heard complaints from basketball players that play at Donovan. They are not able to use half of the court for play when pickleball players are there. Jerry Stevens will be contacted about this.
- 13.2. Director Foley wanted to again thank all staff members. He would like to see some kind of appreciation done now while they are all still working for us.
- 13.3. Directory Newbury-Rediker wanted to share that the members of the Gym Dogs were here helping at gymnastics. One of the girls helping has been nominated by the NCAA as women of the year.
- 13.4. Director Newbury-Rediker had her son help out at the Hill Climb and wanted to acknowledge all the work that goes into a race. The staff puts in long hours to make each event a success. She was very impressed by all the hard work that goes into each event.
- 13.5. Director Newbury-Rediker wanted to inform the board that she is part of a task force that is looking at weekends that are available and how they can bring events for those weekends. She is giving the board a heads up that the task force will be asking for venue dates and what if any dates the board would like to share.
- 13.6. Director Suarez wanted to remind everyone that the Tom Slaughter Golf Tournament will be coming soon. The Vail Recreation District works with the Chambers to put this event on and are currently seeking volunteers. The event will be September 15, 2016. CAPITAL- Projects to date under budget but additional clubhouse costs not yet billed by TOV.

FUND BALANCE- Savings at end of 2015 rolled forward to 2016.

# VAIL RECREATION DISTRICT DIRECTOR REPORTS July 28, 2016

## **GOLF MAINTENANCE**

- The renovated chipping green, practice bunker, and associated areas were opened July 15<sup>th</sup>, only three weeks after sodding. With several sand topdressings we have been able to lower the height of cut on the chipper to .200", or 1/5". It's a little slow and bumpy but will get better as the summer continues and we get it down to the same cutting height as the other greens.
- Planted three new spruce trees on the back of the practice bunker area, to serve
  as a safety screen for errant shots out of the bunker that could potentially hit
  golfers practicing in the approach area of the chipping green surround. We plan
  to add a landscape/flower bed between the trees in the near future.
- Looking to receive a permit to remove some trees along left sides of holes 8, 11, and 12, where overcrowding due to planting too closely many years ago is negatively impacting tree health.
- Gore Creek is at 72 c.f.s. as of today and we are monitoring daily as we move towards potential irrigation restrictions (begins at 30 cfs). Gore Creek was at 156 c.f.s. on 7/11.
- Projects in progress, or soon to be started:
  - Cart path crack sealing is needed. Will try to accomplish that, as well as some overlays on holes 1, 9, and 12, and possibly others.
  - Staining of wooden bridges and other wood components and facilities.

### **GOLF**

- Operations are running smoothly with all staff working together as a team.
   Everyone chips in when needed. Outside staff has heard many positive comments on the new clubhouse. This sentiment has changed quite a bit, now that the building is taking shape and is closer to being complete. Staff continues to park at public works. We have come very close to running out of parking on certain days, but so far, it has worked out that we have had enough spots.
- The junior golf camps are going well. Our beginner camp last week was full with 21 participants. The advanced camp was also full with 9 participants. Our junior programs are continuing to offer excellent instruction in a safe, fun environment. We are seeing many of the same juniors coming out to practice on their own and enjoy the challenge of the game.
- Three of our PGA Interns will be returning to school in three weeks (Cole Underwood, Clint Lackey and Ethan Neumann), with two of our interns staying on for the remaining three months. (Trey Johnson and Derek Bishop) Our interns this season are doing a great job. I hear compliments about them frequently. We also have several college age staff, who will be attending school in August. We plan to hire new staff for the remainder of the year as well as work with Chad Young's summer staff once school starts.

- The daily play on the golf course has been good the past two weeks. We have had several days of 220 golfers. The weather has interfered with our afternoon play on a few days.
- Golf shop retail sales continue to be a bit sluggish, however, golf balls sales are strong as well as rental club revenue. Guests are enjoying the new Callaway rental clubs.
- We continue to hear how great the condition of the golf course is this year. The
  pin placements are a refreshing change as well. Golfers are experiencing some
  new locations of holes on the green this season, which is a change from many
  years of similar pin locations.
- Alice is working with Small Champions again this year. We are offering group lessons on the next four Saturday's.
- Our patrons are enjoying the chipping area and the newly shaped bunker. The short game area opened a week and a half ago.

## **SPORTS REPORT**

- We had quite a few teams use Ford Park Softball facility for the PBR Western Championship baseball tournament from 7/15-17, they absolutely loved the facility and plan to be back next year even bigger. There even was a contingent from Japan here and loved the Vail Valley.
- 45<sup>th</sup> Annual Fred Ammer Vail Invitational Soccer tournament took place this past weekend with 20 teams partaking. The Vail Gold team won their home tournament for the first time in 18 years.
- Upcoming big events on the field include 3v3 Soccer and Rugby Ski Town Tournaments
- The inaugural running festival at Camp Hale included a Half Marathon, 10K and 5K was well received by runners and we look forward to growing that event
- Preparation are going smoothly for the Kids Adventure Games from August 10-14<sup>th</sup>. We are actively recruiting volunteers and need up to 120 ppl a day. Please consider volunteering and help spread the word.
- Camp Hale mountain bike race was cancelled and is rescheduled for July 27<sup>th</sup> after Camp Hale will be the Boneyard Brawl in Eagle on August 3<sup>rd</sup>.

## **MARKETING**

- Jessie is working on adding customer surveys for gymnastics and day camps, in addition to the ones already being done for golf, trail running, whitewater, mountain biking and field events.
- Jessie has been working on a media policy for the VRD, and will be rolling it out to staff shortly, along with conducting media training session for any directors who would like to learn how better to work with media.
- Jessie is working with Suzanne Silverthorne and Chad on children's entertainment and promotion for the Town of Vail 50<sup>th</sup> birthday party and a grand opening for the skate park.
- Jessie has posted the marketing and graphic design specialist position to replace
   Hannah who is going back to school. She is starting to receive resumes and portfolios
   from interested candidates.
- Press releases and emails were sent out for the fall youth soccer programs, Camp Hale HUP mountain bike race, Camp Hale half marathon and trail running races, soccer and basketball camps.

The VRD was featured numerous times in the Vail Daily recently including a front page
photo of the Vail Hill Climb race, race write-up and results, plus daily calendar events.
Ads are running regularly in the local newspapers and on the local radio stations, plus
a full digital and social media marketing plan is in place.

## DOBSON

- The Vail Skating Invitational went great. Nothing but positive comments coming from the SCV regarding our staff's effort to make it a great event.
- Bob Johnson Hockey School was sold out (actually over sold) once again. We
  had another great week. We had 116 registered participants. It is always the best
  week of the year in all categories having the Johnson family in the rink.
- July 8th we had another successful Hispanic dance with 690 attendees...
- We are still looking ahead to another 3 weeks of business before school gets started.

## **COMMUNITY PROGRAMMING**

## Community Programming

- Imagination Station is fairly busy (3-8 families) every day with some very busy days when weather is bad and/or a camp or two comes in.
- We are continuing with Gentle Yoga, TRX and Aikido through the summer season.
- Camp Vail is visiting for cooking, pottery, and science. Other camps such as Beaver Creek, Avon and Idaho Springs are also coming in to play, do science experiments and pottery.

## <u>Camps</u>

- All staff are trained and executing camps well.
- Camp Vail, Pre Kamp Vail and Camp Eco Fun are at or near capacity for all the rest of the summer.
- Skateboard Clinics began 7/12, and 7/19. The town has a CO.

## Other

- We are finalizing the skate park memorial plaque and signs with Susan Mitchell and the Town of Vail. We have the signs on the way, and Chad is coordinating with Cameron Chaney to have him at the Skate Park Dedication and Grand Opening events if at all possible. We have a date of September 10 for the dedication and we are still finalizing the date of the Grand Opening.
- The TOV streets crew is doing daily maintenance on the skate park. We just got
  a request from the town that has the VRD in charge of daily maintenance and
  sweep.
- We had the first summer Cocktails & Canvas program on Thursday 7/14 Wine Glass etching. This is in partnership with the TOV Library and Alpine Arts Center.
- We are working with Suzanne Silverthorne to help program the TOV Birthday Party on August 23. We will provide a Bounce House, crafts, carnival games with prizes and staffing for all.

# Marketing/Photos (Tooting Our Own Horn)

 Counselors are taking good photos and we are giving prints away in all camps and posting photos to our Facebook page.

## **GYMNASTICS**

- Vail Gymnastics Center has successfully held 3 out of 4 public gymnastics camps so far this summer. All public camps are full at 45 participants which is the highest it has been in several years.
- The competitive team has completed 2 out of their 3 camps. The most recent camp hosted by two of the University of Georgia Gym Dogs, Mary Beth Box and Beth Roberts. Mary Beth was recently nominated as the NCAA female athlete of the year.
- Tani Blount, former coach of Olympian Carly Patterson will be returning for our August 8<sup>th</sup>-12<sup>th</sup> camp.
